**SUBJECT: Revocation of American Express Corporate Card**

Dear Cardmember,

We are writing to inform you that, following the termination of the relationship between American Express Global Commercial Services and the Institution where you are employed, we will cancel the American Express Corporate Card issued in your name **on July 31, 2021**. For any further information regarding the reasons for this decision, we ask you to contact your company representative directly.

In the event that your Corporate Card is enrolled in the Club Membership Rewards® you will have to choose one of the two options shown below for the management of any Membership Rewards points already accrued.

**Option 1:** If **you wish to retain your Membership Rewards points**, you may transfer them by **September 29, 2021** to a new personal American Express Card (or other American Express Card, enrolled in Club Membership Rewards), issued in your name, as per the relevant regulations available on the website **[americanexpress.it/clubmr](http://americanexpress.it/clubmr)**. For more information, contact American Express Customer Service at 06 72 900 769 (call cost according to the caller's personal pricing plan) from 8:00 a.m. to 10:00 p.m. Monday through Sunday (excluding holidays).

**Option 2:** If you **do not intend to transfer your Membership Rewards points** as described in the option 1 above, you must **use them by July 31, 2021** by contacting American Express Customer Service (as indicated in the previous point). In this case, you can choose from a wide range of rewards from different categories, **[www.americanexpress.it/premi](http://www.americanexpress.it/premi)**.

If Membership Rewards points are not used or transferred within the dates mentioned through one of the indicated options, they can no longer be used.
